Delay in Indian Airlines Flight from Bombay to Calcutta due to Bomb Scare

THE MINISTER OF YOURISM AND CIVIL AVIATION (DR. KARAN SINGH): (a) Yes, Sir.

(b) On May 2, 1972 at about 1700 hours, 15 minutes before the schedu'rd departure of Indian Airlines flight IC:175--Bombay/Calcutta--which is operated with an Air-India 707 on charter to Indian Airlines, a staff member in Indian Airlines traffic office at Bombay received an anonymous telephone call in Hindi to the effect that "your aircraft to Calcutta will not reach safely and that all the passengers will be killed." The caller immediately disconnected.

Immediately on receipt of this message it was decided to carry out anti-sabotage checks. The passengers, who had boarded the aircraft, deplaned and cargo and mail were off-loaded. A thorough security check was made in accordance with the prescribed procedure. A personal search of passengers, as also of their baggage and handbaggage was carried out. Nothing incriminating was found and the flight left 1 hour 45 minutes behind schedule,
