Loans and advances to states from the Reserve Bank of India.

(a) whether there has been a sharp decline in the loans uad advances of the Reserve Bank of India to the State Governments; and

THE MINISTER OF FINANCE (SHRI YESHWANTRAO CHAVAN) (a) and (b). The outstanding loans and advances to State Governments from the Reserve Bank of India including advances from the Bank's National Agricultural Credit (Long Term Operations) Fund and overdrafts which stood at Rs. 762 42 crores as on 28th April, 1972 have come down to Rs. 100.28 crores as on 19th May, 1972. The reduction is mostly on account of the clearance of the State Governments' overtrafts.
