THE MINISTER OF STATE IN THE MINISTRY OF WORKS AND HOUSING (SHRI I. K. GUJRAL): (a) A Statement is laid on the Table of the House. [Placed in library. See No. LT-3079/72]

(b) According to the survey conducted by the Delhi Municipal Corporation (in 1967) of the 101 unauthorised colonies which had come into existence between 1st September, 1962 and 31st January, 1967, the Laxmi Nagar Colony at Patpargani Road does not cover "Laxmi Nagar '1' Extension Colony".

Plastic Silos Being Sold by P. C. I

7675. SHRI DEVINDER SINGH GARCHA: Will the Minister of AGRI-CULTURE be pleased to state:

- (a) whether Plastic silos to protect foodgrains manufactured by a private firm are being sold by Food Corporation of India;
- (b) if so, whether the Food Corporation will be in a position to meet the entire demand of the country and the estimated demand; and
- (c) if not, whether any other firm has applied for the manufacture of plastic siles, if so, the main features thereof?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHR I ANNASAHEB F. SHINDE): (a) No, Sir. The Food Corporation of India and the Central Food Technological Research Institute, Mysore, have, however, jointly worked on developing plastic silos in association with one private firm (viz, Polyene Industries) having facilities for manufacturing these silos. So far only a few demonstrations have been arranged about the utility of such silos at the farm level.

- (b) this is only a promotional activity designed to check wastage of foodgrains during storage and hence the question as to whether the F. C. I. will be in a position to meet the entire demand of the country does not arise.
- (c) the fabrication of plastic silos at this stage is only of an exploratory nature and in the preliminary stage of experimentation and no other firm has applied so far.
