कृषि मंत्रालय में राज्य मंत्री (भी धन्या-साह्ब पी० शिन्दे): (क) ग्रीर (ल), भारत सरकार द्वारा श्रीलल भारतीय सर्वदलीय गोरला महाभियान समिति के महामन्त्री को दिनांक 3-2-67 को भेजे गये पत्र की एक प्रति ग्रीर इस पत्र के साथ भेजे गये विवरण की एक प्रति सभा पटल पर रखी जाती है। [ग्रन्थालय में रखी गयी। देखिये संस्था LT-3082/72]

(ग) भारत सरकार ऐसे राज्य सरकारों को अनुरोध करती रही है जिन्होने गोवध प्रतिबन्ध नहीं लगाया है या आंधिक प्रतिबन्ध लगाया है कि वे संविधान के अनुच्छेद 48 की शीध्र पूर्ति के लिये गायों, बछड़ों और अन्य दुधार और भारवहन पशुओं के वध पर प्रतिबन्ध लगाने के सिए कदम जठायें।

भारत सरकार ने एक गोरक्षा समिति भी बनाई है जो गाय तथा उसकी सतित के वष पर पूर्ण प्रतिबन्ध लगाने के प्रश्न के सब पहलुझों पर झन्य बातों के साथ-साथ, विचार करेगी। समिति को धपनी रिपोर्ट 31-3-73 तक हेनी है।

Termination of Punjabi Language Teachers by Director of Education, Deibi

7709. SHRI B. S. BHAURA: Will the Minister of EDUCATION AND SOCIAL WELFARE be pleased to state:

- (a) whether the Director of Eduction, Delhi Administration has issued instructions to terminate services of Punjabi language teachers appointed on ad hoc basis, from 30th April, 1972; and
 - (b) if so, the reasons therefor?

THE DEPUTY MINISTER IN THE MINISTRY OF EDUCATION AND SOCIAL WELFARE AND IN THE DEPARTMENT OF CULTURE (SHRI D. P. YADAV): (a) and (b), Due to a stay order about the promotion of teachers transferred from the Municipal Corporation of Delhi, the Principals of the Schools were authorised to fill the short term vacuncies on purely temporary basis so that the teaching work in the schools may not suffer. These appointments were made by the Principals concerned on the clear understanding that their (ad-hoc teachers') service will be terminated as soon as remited incumbents posted by the Directorate of Education join or 30-4-1972, whichever is earlier. In pursuance of these orders, sevices of all such incumbents of all categories including Punjabi Language Teachers stand terminated with effect 30 4-72. No separate specific orders were issued to terminate the services of Language Teachers puniabi.
