adopted on the basis of decision and action on the part of the individual farmer. The new agronomy of wheat, for example, can be adopted successfully by any farmer who has access to the needed inputs. Similarly the multiple cropping pattern can also be successfully adopted by the farmers irrespective of their size of holdings, provided they can mobilise credit and other inputs.

- (c) The pattern of Co operative endeavour that has to be generated will vary from area to area. State Governments will have to take appropriate action
- (d) The Minister of Agriculture, Government of India, as well as the State Governments have launched a number of developmental schemes through which the new technology is being popularized for country-wide adoption. Examples are the High-Yielding Varieties Programme, Intensive Cotton District Programme, pilot projects in Dryland Farming and Multiple Cropping and Small and Marginal Farmers Scheme

Sium Clearance Policy in Delhi

7827 SHRI R. S. PANDEY: Will the Minister of WORKS AND HOUSING be pleased to state:

- (a) whether the slum clearance policy pursued so far has not proved vey successful as large areas in the capital have developed into slums
- (b) whether Government have formulated any measures for speedy removal of the slums from the capital and if so, main features thereof, and
- (c) whether any measures have also been worked to provide proper rehabilitation to people when removed from the slum areas?

THE MINISTER OF STATE IN THE MINISTRY OF WORKS AND HOUS-ING (SHRI 1 K. GUJRAL). (a) The problems of slums in the capital is gigantic. However, within the funds provided for Slum Clearance/Improvement Scheme in Delhi, some measure of success has been achieved,

- (b) Slum dwellers has generally resisted programmes of slum clearance. In the new scheme for environmental improvement of slum areas an allocation of Rs. 2.5 crores has been earmarked during the current year for carrying out improvements in such slum areas in the capital as cannot be cleared in the foreseeable future
- (c) To the extent possible, residents of slum areas which are earmarked for clea
