THE MINISTER OF STATE IN THE MINISTRY OF STEEL AND MINES (SHRI SHAH NAWAZ KHAN). (a) The question presumbly refers to the erection of the 6000 Tonnes Press in Foundry Forge Plant. This was due to be completed by the end of December, 1971 and commissioned by March, 1972 The press is now expected to be commissioned by the end of may, 1972.

(b) The delay has been mainly due to the late receipt of certain vital imported components and lack of sufficient skilled manpower with the contractor for the crectrion of electrical and mechanical components.

# Death of a Worker of Wagon Repair shop of Rourkeia Steel Plant

(a) whether one Shri Sukura Tanti of Wagon Repair Shop, Rourkela Steel Plant died in the afternoon of 11th February, 1972 in an accident, and

(b) if so, whether any enquiry has been conducted into the case of the accident and the responsibility fixed ?

THE MINISTER OF STATE IN THE MINISTRY ON STEEL AND MINES (SHRI SHAH NAWAZ KHAN): (a) Yes, Sir Shri Tanti met with a serious accident in the Rourkela Steel Plant on 11 2.1972 at 2 00 P M, while removing the housing of the Siag Car. He was removed to hospital where he died at 8.00 P.M. on the same day

(b) A Committee consisting of three Senior Officers of the Plant conducted an enquiry and found that the death of Shri Tanti was accidental.

### Publication of Advertisements in Dailies for Workers of Rourksia Steel Plant

THE MINISTER OF STATE IN THE MINISTRY OF STEEL AND MINES (SHRI SHAH NAWAZ KHAN): (a) and (b). A Notification "Why Rourkela Steel Plant Security Personnel should opt for Central Industrial Security Force" was published in three English and five Oriya dailies, and in one weekly each in English and Oriya, at a cost of Rs. 7,410.

The Notification was issued not only to infom the Security Personnel about the last date for exercising their option to join the Central Industrial Security Force, but also to clarify to them, the other workers of the Plant and the general public the position in regard to the terms and conditions of service in the Central Industrial Security Force.

#### Life Insurance for Labourers
