(Chittoor District), Thogurupet (Cuddapah District). Papaghim Reservoir (Anantapur and Cuddapah District) of Andhra Pradesh have been approved by the Planning Commission and the Central water and Power Commission; and

(b) the area to be irrigated by each of these schemes and the estimated expenditure to be incurred on them?

THE DEPUTY MINISTER IN THE MINISTRY OF IRRIGATION AND POWER (SHRI B. N. KUREEL): (a) and (b). The Gaiuladine project was approved in 1966 for irrigating 12,500 acres; the project was estimated to cost Rs. 96:36 lakhs

The other schemes have not been sent by the Government of Andhra Pradesh to the Centre.

Payment of Exgratia grants to Indian citizens whose properties were seized in Pakistan

THE DEPUTY MINISTER IN THE MINISTRY OF FOREIGN TRADE (SHRI A. C. GEORGE): (a) and (b). A total number of 166 claims involving a payment of Rs. 1,58,26,354 have so far been verified for payment of ex-gratia grant and a sum of Rs. 1.05.82.574 has been distributed to the various claimants.

- (c) Yes, Sir, Some internal guidelines as to the factors which should be taken into account were agreed upon at an inter-departmental meeting of officials. In view of the many variables, it would not be in the public interest to disclose this information which is intended only for internal use.
- (d) Four parties have so far requested for consideration of their claims on merit basis. The cases of two parties have been rejected. The cases of the remaining two are under consideration
