# Revision of minimum Support Price for Raw Jute

## 300 SHRI JYOTIRMOY BOSU : SHRI B K DASCHRWDHURY:

Will the Minister of FOREIGN TRADE be pleased to state:

- (a) whether Government have made any estimate of the cost of raw jute production,
- (b) if so, the details thereof and the method adopted for arriving at the said estimate.
- (c) whether his attention has been drawn to widespread resentment in West Bengal over the decision of Government to fix the minimum support price at Rs 115; and
- (d) if so, whether Government propose to make an upward revision of the minimum support price?

THE DLPUTY MINISTER IN THE M NISTRY OF FORLIGN TRADE (SHRI A C GEORGE) (a) and (b) On the passis of Farm Management Study carried out in Hooghly and 24 Parganas districts of West Bengal, the cost of production of raw jute was estimated at Rs 68 37 per quintal oa account of total cost for the period 1955-56 and 1956-57 Another comprehensive study of cost of production of raw jute is expected to be takn up in 1973 74.

- (c) No, Sir The West Bengal Govt. had, however, suggested fixation of a higher minimum price
- (d) It is proposed to review the minimum prices after 2 months.

### Notice of peaceful agitation from Pong Dam oustees

- (a) whether a notice for a peaceful agipation has been received by Government from the Oustees of the Pong Dam Area,

(b) if so, the reaction of Government thereto?

THE DEPUTY MINISTER IN THE MINISTRY OF IRRIGATION AND POWER (SHRI B N KUREEL) (a) and (b). A notice for starting peaceful agitation was received in June, 1972 but this did not specify the demands However, in an earlier communication dated 22nd October, 1971, from the Pong Dam Oustees Committee Mangwal, certain demands were made The more important of these demands relating to acquisition of land and payment of awarded amounts have since been largely fulfilled

#### Working of Railway Out-Agencies in Himachal Pradesh

- (a) whether a request has been received by Government to resume the working of Railway Out-Agencies in Himachal Pradesh, and
- (b) if so, Government's decision m the matter?

MINISTER OF RAILWAYS (SHRIT A PAI) (a) and (b). Presumably the question pertains to the out agencies at Gagret, Bharwain, Pragpur, Jwalamukhi Mandir and Nadaun in Himachal pradesh which were closed in August, 1967 Requests have been received from the public for reopening these out agencies. This has not been possible because no contractor could be found to work the out agencies due to poor traffic prospects However, the Mandi Kulu Road Transport Corporation have agreed to work the out agencies on an experimental basis The matter is being pursued with Corporation.

#### New Railway lines in hilly and backward areas
