Following enquiries from several foreign countries for purchase of Alumina from India on a long term basis, the National Industrial Development Corporation was commissioned to prepare a detailed Techno-Economic Feasibility Report for an export-oriented Alumina Plant in Gujarat Since the cost estimates indicated in the Feasibility Report prepared in 1969 have become outdated, the cost estimates as well as the demand of both internal and external markets are at present being reexamined
