Production of Ingots and Saleable Steel in Public Sector Steel Plants

673. SHRI K. BALADHANDA-UTHAM:

SHRI RAMAVATAR SHAS-TRI:

Will the Minister of STEEL AND MINES be pleased to state:

(a) whether the aggregate production of ingots and saleable steel at the country's three mild steel plants showed a decline in the months of April to June this year:

- (b) if so, the reasons for the decline in production; and
- (c) the steps taken to step up production of ingots and saleable steel at these plants?

THE MINISTER OF STATE IN THE MINISTRY OF STEEL AND MINES (SHRI SHAHNAWAZ KHAN): The aggregate production at the Bhilai, Durgapur, Rourkela Steel Plants under Hindustan Steel Limited during the months of April to June, 1972, was higher m terms of saleable steel but lower in terms of ingot steel as compared to the production in the corresponding period last year as the following figures will show:—

- (h) The production during these months was affected in all the plants on account of a severe summer, high absenteers and shortage of coke oven gas Power shortage due to restrictions in supply affected production in Kourkela and Durgapur. Adverse industrial relations constituted a principal constraint in the Durgapur Steel Plant and to some extent, affected the Rourkela Steel Plant also.
- (c) Within the limitations imposed by the industrial relations situation, particularly at Durgapur Steel Plant, the Management of Hindustan Steel Limited are making all possible efforts to increase production as rapidly as possible. These includes: specialised repairs of Coke Ovens, use of alternative fuels to supplement gas availability, oil firing in certain furnaces to augment fuel resources, improved maintenance aimed at better equipment availability, speeding up of capital programmes required to correct existing imbalances in production facilities and planned procurement of spares, refractories and other essential materials. Recently, a three-tier joint consultative machinery has been set up at Durgapur for speedy settlement of industrial disputes and grievances and to enlist the cooperation of the workers in maximizing production. A new rewards scheme has been introduced in the Rourkela Steel Plant to

provide an additional incentive for increasing production progressively.
