Production in Neyvell Lignite Corporation

682. SHRI N. K. SANGHI:

SHRI JAGANNATH MISHRA:

Will the Minister of STEEL AND MINES be pleased to state:

- (a) whether the Neyveli Lignite Corporation is progressively running into loss due to production being decreased year after year.
- (b) the total investment in the integrated project and the accumulated loss so far;
- (c) whether Government have considered the recommendations of Prof. Subramaniam Committee to revitalise the Project; and
- (d) if so, the steps taken to run the project profitably.

THE MINISTER OF STATE IN THE MINISTRY OF STEEL AND MINIES (SHRI SHAHNAWAZ KHAN): (a) No. The Neyveli Lignite Corporation continues to sustain losses due to decrease in production. The production figures for the past four years and the losses for these years are furnished below:—

The accumulated loss incurred upto 31-3-72 is Rs. 4490.72 lakhs (which includes amount of Rs. 1237.83 lakhs being the provisional figures for 1971-72).

- (c) Yes, Sir.
- (d) The following steps are being taken by the Government to revitalise the project:—
 - (i) The Corporation is procuring additional mining equipments for
- increasing the production of Lignite from the present level of 3.6 million tonnes to 4.2 million tonnes in 1973-74 & to 4.5 million tonnes from 74-75 onwards
- (ii) A detailed project report is also being prepared for stapping up the production of Lignite further to 6.5 million tonnes per year.
- (iii) As recommended by Prof. Subramaniam Committee, forward preparation of ground is being inten-

sified by increased blasting to improve the overburden output from mines. For this, 2 drills are already on order and other 2 more drills are also being procured.

- (iv) The mines are being reorganised with a view to achieve better utilisation of mining equipment and reduction in the level of expenditure.
- (v) Government has set up a committee to examine the feasibility of converting some units in the thermal power station of Neyveli Lignite Corporation to coal or oil firing.

Recognition of P.R.G. of South Vietnam

THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI SURENDRA PAL SINGH): (a) to (c). Government of India's stand on the question as stated in the House in reply to Starred Question No. 52 of 16th March, 1972 still stands in view of the fluid situation prevailing in South Vietnam.

Strike by Artisans of H.E.C., Ranchi

684. SHRI MOHAMMAD ISMAIL: SHRI HARI SINGH:

Will the Minister of STEEL AND MINES be pleased to state:

- (a) whether the artisans of Heavy Engineering Corporation, Ranchi went on tool-down strike in May;
 - (b) if so, the reasons thereof;
- (c) whether the local authorities prohibited the artisans from entering the factory; if so, the reasons thereof; and

(d) the steps taken by Government to meet the demands of the artisans?

THE MINISTER OF STATE IN THE MINISTRY OF STEEL AND MINES (SHRI SHAHNAWAZ KHAN): (a) Only the artisans trained in the Central Training Institute' went on a tool down strike in May.

- (b) As some of the demands of those artisans relating to conditions of service were considered unreasonable and were not conceded by the HEC management, a tool down strike was resorted to.
- (c) Yes. The striking artisans were causing serious obstruction to work and were not allowing other willing workers to operate the machines.
- (d) In such matters Government encourages the management and the employees to negotiate and reach a settlement. As a result of conculation proceedings held by the Labour Commissioner, Government of Bihar, a settlement was reached and the striking artisans have called off their strike and resumed work on 11th July, 1972. Since then a round of discussions between HEC management and the HEC Artisans Association has taken place. A settlement has been reached in respect to some of the demands. The help of the Department of Labour, Government of Bihar has been sought by the management for a settlement of rest of the demands.
