Salvage of Sub-Standard Rice unearthed in West Bengal

2033. SHRI N. K. SANGHI: Will the Minister of AGRICULTURE he picased to state how much of the sub-standard rice uncarthed from Food Corporation of India Godown in West Bengal could be salvaged and how the rest has been disposed of?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI ANNASAHEB P. SHINDE): The stocks of non-Bengal raw rice are subjected to pre-inspection by the State Government's Inspectors in the godowns of the Food Corporation of India in West Bengal. Such stocks as are declared as sub-standard judged by the State Government's specifications which are slightly more stringent than the uniform specifications of the Government of India, are subjected to cleaning through the cleaning machines. As such, the cleaning of non-Bengal raw rice before issue has become a regular feature. The rice after cleaning is accepted by the State Government. The fine dust and small brookens collected as a result of cleaning are disposed of as poultry feed in accordance with the standing procedure.

The actual quantity cleaned and issued during this year as a result of pre-inspection by the State Government is being ascertained.
