Written Answers

RLECTRONICS, MINISTER OF HOME APPAIRS, MINISTER OF INFORMATION AND BROADCASTING AND MINISTER OF SPACE (SHRIMATI INDIRA GANDHI): (a) to (c). Government has decided to set up an atomic power station at Narors in Western Uttar Pradesh The station will consist of two units of 235 MWe each.

A working group appointed by the Atomic Energy Commission to evaluate the concept of nuclear-powered agro-industrial complexes has submitted its report. Among the projects studied by the working group are those relating to the eastablishment of such complexes in the Gangetic plain as well as in the Kutch-Saurashtra region. Further-detailed studies on these projects are in progress

In connection with the feasibility studies relating to Western Uttar Pradesh, it has been decided to investigate the availability and scientific exploitation of underground water from this area. This study has not yet been completed.

# Machinery for Satisfactory Planning and Coordination of Plan Publicity

2290. SHRI S. C. SAMANTA: Will the Minuter of PLANNING be pleased to state:

- (a) the machinery evolved for satisfactory planning and coordination of Pian Publicity, and
- (b) the publicity media aims of the 5th Plan?

THE MINISTER OF STATE IN THE MINISTRY OF PLANNING (SHRI MOHAN DHARIA): (a) Plan Publicity Schemes are planned and implemented by the media units of the Ministry of Information and Broadcasting at the Centre and the Publicity Departments in the States. There are a few scheme which are part of the programmes of other developmental Ministries such as Health and Pamily Planning. They have the benefit of the Planning Commission's advice in the process of planning and coordinated implementation.

(b) The publicity Schemes for the Fifth Plan are being formulated by the runs, communication media units of the Information and Breadcasting Ministry at the Contra and the publicity Departments in States.

#### Take over of whole sale trade of commumer Goods

THE DEPUTY MINISTER IN THE MINISTRY OF INDUSTRIAL DEVELOP-MENT (SHRI SIDDHESHWAR PRASAD):
(a) and (b). Government have under consideration a scheme for maintaining price stability and ensuring availability of essential commodities at reasonable prices. This scheme includes, inter-alia, recommendations about the role of the public sector in the wholesale trade in certain essential consumer goods.

- (a) whether any site has been selected by the Site Selection Committee for setting up nuclear power station in Western, Northern and Southern regions; and
- (b) if so, their locations and when the work is likely to be started?

THE PRIME MINISTER, MINISTER OF ATOMIC ENERGY, MINISTER OF ELECTRONICS, MINISTER OF HOME AFFAIRS, MINISTER OF INFORMATOIN AND BROADCASTING AND MINISTER OF SPACE (SHRIMATI INDIRA GANDHI): (a) and (b). The Site Selection Committee has so far made recommendations only in regard to the Northern Region. The survey in regard to the Western and Southern Regions is still in progress. The Atomic Power Station in the Northern Region will be located at Narora in Western Uttar Pracion.

investigations at the site and collection of data for the design of the Power Station has been taken up.

### Change in the name of Mysore to Karnetaka

## Survey of Radioactive Minerals

2294. SHRI B V. NAIK: Will the Minister of ATOMIC ENERGY be pleased to state :

- (a) whether a survey of radioactive minerals was undertaken all along the coastal regions of India;
  - (b) if so, the findings of this survey; and
- (c) whether there is any other source than monazite sands?

THE PRIME MINISTER, MINISTER OF ATOMIC ENERGY, MINISTER OF ELECTRONICS, MINISTER OF HOME AFFAIRS, MINISTER OF INFORMATION AND BROADCASTING AND MINISTER OF SPACE (SHRIMATI INDIRA GANDHI): (a) Yes, Sir. Surveys have been conducted by the Atomic Minerals Division of the Department of Atomic Energy for radioactive minerals along the Indian Sea Board as a part of a continuing programme of investigations for such minerals.

(b) Deposits of monazite associated with other constituent minerals of beach sands such as ilmenite, rutile, sircon allimenite. kyanite, etc. have been located in noteworthy concentrations in certain parts of the constal tract.

there is no known source of radio-active minerals other than monazite sands.
