THE DEPUTY MINISTER IN THE MINISTRY OF HOME **AFFAIRS** (SHRI F. H. MOHSIN): (a) Yes, Sir. The Delhi Administration have received representations from certain residents of Bali Nagar and the Principal, Rajdhani College, Kirti Nagar, New Delhi. against the opening of the liquor shop.

(b) The Administration have considered their representations. Selection of the site for location of country liquor shop was made keeping in views its remoteness from religious places and educational institutions, concentration of demand for country liquors, security from law and order point of view, etc. Delhi Administration have reported that this shop is away from the Rajdhani College and other local colleges and residential localities.
