A strict watch is kept on the activities of all organisations and appropriate action under law is being taken whenever necessary.

Posts in Calcutta Station of A.I.R. Lying Vacant

- (a) whether ten posts in Calcutta Station of A. I. R. are lying vacant for years together and if so how with this shortage of staff the Calcutta station can discharge its duties;
- (b) whether the Ministry is aware of long standing grievances of the staff artistes of Calcutta Station of A. I. R. that they do not get the senior scale even after serving for a long time, if so, Government's reaction thereto;
