THE MINISTER OF INDUSTRIAL DEVELOPMENT AND SCIENCE AND TECHNOLOGY (SHRI C. SUB-RAMANIAM): (a) to (c). The conversion of a Letter of Intent into an Industrial Licence depends on the fulfilment by the party of the conditions

imposed in the letter of intent. Industrial Licences are issued within a reasonable period after these conditions are fulfilled. In order to ensure speedy implementation of the conditions of letters of intent, a condition is being imposed since August, 1972 in all letters of intent to the effect that the progresss of implementation of the scheme should be reported to Government every three months.

"Instant Broadcasting Station" being marketed by American firm

- (b) if so, the broad outlines thereof and efforts made by Government to acquire such equipment?

THE DEPUTY MINISTER IN THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI DHARAM BIR SINHA) (a) Yes, Sir, There have been reports in the Press of an "Instant Broadcasting Station" being marketed by an American firm

(b) According to Press reports, the Instant Broadcasting Station" consists of a 1,000 watt FM transmitter, antenna and speech input equipment. It is claimed that it can be put into operation within 90 days after the order is received by the firm. The cost is about \$15,000.

The utility of this equipment in present Indian conditions will be limited since apart from requiring FM receiving sets for listening, it will only help to cover small localities falling within the shadow zones of main transmitting stations Moreover, All India Radio depends mainly on indigenously manufactured equipment. It is therefore not proposed to acquire this equipment.
