THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS AND IN THE DEPARTMENT OF PERSON-NEL (SHRI RAM NIWAS MIRDHA) (a) to (c) On a suggestion made by the Secretary of the Staff Side of the National Council, in his letter of 17th November, 1972 for arranging a meeting between the Chairman of the National Council (Cabinet Secretary) and the Standing Committee of the Staff Side a meeting was fixed for the 7th December, 1972 It was, however. intimated by the Secretary of the Staff Side on the 7th December, that some of the members of the Standing Committee were far away from Delhi and it would not be possible for them to attend the meeting He however desired that, in the mentime, Govern-ment's decision on the issues which created a deadlock in the meeting of the National Council on the 29th July, 1972 be communicated to him Chairman in his letter of 8th December, 1972 informed the Secretary of the Staff Side that a meeting for discussing the outstanding matters could -
