Production cost of an aircraft manufactured at H.A.L., Bangalore

Written Answers

4310. SHRI JYOTIRMOY BOSU: Will the Minister of DEFENCE be pleased to state:

- (a) the cost of an aircraft manufactured at Hindustan Aeronautics Ltd., Bangalore;
- (b) the comparative cost of an imported aircraft;
- (c) whether the former is costlier than the latter; and
- (d) if so, the factors responsible for the same?

THE MINISTER OF STATE (DE-FENCE PRODUCTION) IN THE MIN-ISTRY OF DEFENCE (SHRI VIDYA CHARAN SHUKLA): (a) to (c). HAL mainly manufactures aircraft for meeting defence needs. It will not be in the public interest to disclose details of cost in these cases. In the case of aircraft manufactured under licence, the cost of production of HAL aircraft at the raw material stage is generally comparable with the price of similar aircraft if imported. However in the case of HS 748, where the number of aircraft to be manufactured is limited. the HAL cost is somewhat higher.

(d) The higher cost is due to the comparatively limited number to be produced and consequent higher amortisation. There is also the absence of a well developed industrial infrastructure of supporting industries for the supply of aircraft materials, equipment and accessories, most of which have to be imported.

Among the steps taken to reduce the cost of production are to increase the productivity in HAL by greater attention to production planning and scheduling, incentive schemes training etc. Several measures have also been initiated for development of indigenous substitutes for imported materials and components to the extent possible and also for the manufacture of various kinds of aircraft accessories within the country.
