## Hoarding of Baby Tinned Milk Food

4356. SHRI R. P. YADAV: Will the Minister of COMMERCE be pleased to state:

(a) whether Government are aware that a large number of traders and business-men are hoarding baby tunned milk food in Bihar and selling it at exorbitantly high price; and

(b) whether Government contemplate any action to checkmate the black marketeers and adopt some alternative means of distribution through cooperative societies?

THE DEPUTY MINISTER IN THE MINISTRY OF COMMERCE (SHRI A. C GEORGE): (a) and (b). According to information received from the Government of Bihar, no report about selling at exhorbitant prices and hoarding of baby tinned milk food has been received so far, and baby tinned milk food is being sold in the State through Co-operative Societies also besides Private bodies.

## Quantity of Sulphur imported from Iraq

(a) the quantity of sulphur India is importing from Iraq;

(b) whether Iraq has requested Indua to step up the quantity; and

THE DEPUTY MINISTER IN THE MINISTRY OF COMMERCE (SHRI A. C. GEORGE): (a) The Minerals and Metals Trading Corporation has concluded a contract for import of one lakh tonnes of sulphur from Iraq.

(b) and (c). Iraq has indicated to the MMTC that they will be interested in supplying higher quantities of sulphur in the future but no specific proposal has been made by them in this behalf.

## **Export Price of Steel Pipes and Tubes**

4358. SHRI SOMCHAND SOLAN-KI: Will the Minister of COMMERCE be pleased to state:

(a) whether the export price of steel pipes and tubes are competitive with prices of other countries and the internal prices of steel pipes and tubes sold in our country;

(b) m case the export prices of the above items are less, how the exporters are benefited by selling it outside the country at the lower prices; and

(c) how much and on what items the subsidy is being given to the exporters, who are selling at low prices?

THE DEPUTY MINISTER IN THE MINISTRY OF COMMERCE (SHR] A. C. GEORGE): (a) to (c). The export prices of steel pipes and tubes are competitive with those of foreign countries even though they are lower compared to domestic prices. The exporters cover the price gap between export price and internal price by drawback of duties, import replenishments and compensatory support given by the Goverment. These exports help the industry to utilise idle capacity to a great extent
