- (a) the progress made in the construction of Railway line from Takapur to Bageshwar in the Hill Districts of Uttar Pradesh:
- (b) the number of persons in different grades employed on this project and the number of local persons among them in each category, separately; and
- (c) the schedule of completion of this project?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI MOHD. SHAFI QURESHI). (a) This line has not been taken up for construction.

(b) and (c). Do not arise, 4078 LS-8.

Execution of work on Mineri Theri and Pachheshwar Dams in U.P.

4908. SHRI NARENDRA SINGH BISHT: Will the Minister of IRRIGA-TION AND POWER be pleased to state:

- (a) the present position of the execution of work on Maneri, Tehri and Pachheshwar dams in the Districts of Uttarkashi, Tehri-Garhwal and Pithoragarh respectively;
- (b) the irrigation of power potentially of these dams, the areas proposed to be brought under irrigation and electrified by these dams; and
- (c) the porposed outlay on the works, employment potentiality and schedule for completion?

THE DEPUTY MINISTER IN THE

MINISTRY OF IRRIGATION AND POWER (SHRI BALGOVIND VERMA):

(a) Prelimmery work in respect of Maneri Project Stage I has already been completed and main work has been started from 15-1-73. As regarded Tehri Project, preliminery works such as approach roads etc. On Government land have been taken up. Action is also being taken to acquire private land. The Pachheshwar dam project has not yet been sanctioned, As the project is located on the boundary of India and Nepal,

an agreement has to be reached between

India and Nepal, for taking up work on

the project.

- (b) Power potentials of Maneri Project Stage I and Tehri project are 93 MW and 600 MW. The Power Station at Pachheswar would have an initial installed capacity of 1000 MW. (4×250 MW) with provision of addition of 4 more units at a future date. The power generated will be fed into the Northern Grid.
- 2.7 lakhs Hectares of new areas will benefit from Tehri Dam and Irrigation about 13.0 lakhs hectares will be intentified.
