8517. SHRI R. N. BARMAN: Will the Minister of FINANCE be pleasred to state:

(a) whether the State of West Bengal is not included in the list of beneficiaries of the recent loan of \$93 million to India by the International Development Association, an .affiliate body of the World Bank;

(b) if so, the reasons therefor; and

(c) whether Government propose to give assistance out of the aforesaid loan amount to the State of West Bengal for development work?

THE MINISTER OF FINANCE (SHRI YESWANTRAO CHAVAN): (a) to (c). Two Credits were approved by the Board of Directors of the International Development Asso-, ciation (IDA). One of US Dollar 8 million, is meant for development of agricultural wholesale markets in Mysore State. The other, of US Dollars 85 millions, will be utilised for expansion of power transmission programmes of certain State Electricity Boards, which do not include West Bengal. The West Bengal State Electricity Board is already one of the beneficiaries of an IDA Credit for India's Second Power Transmission Project given in May 1971. Proposals for IDA Credits for Urban Development and Agricultural markets development projects in West Bengal are separately under consideration.

(b) No survey was undertaken by the Tea Board on the Eonomic Conditions of the Tea Estates. In addition to the Tea Machinery Hire Purchase Scheme and the Plantation Finance Scheme which were available to all Sections of the Tea Industry big and small since the early sixties, a new Scheme viz., Replantation Subsidy Scheme was introduced in October. 1968 to assist the industry in undertaking replanting of overaged tea areas. This Scheme provided subsidy to be paid to any garden big or small that desired to replant existing tea areas.

(c) During the last 3 years several visits were paid by officials of Tea Board to various tea areas in Assam and West Bengal like Tezpur, Jorhat, Cachar, Dibrugah, Dooars and Darjeeling in Eastern India.
