- (iv) Immunisation of expectant mothers against Tetanus.
- (i) Vaccination against Smallpox.-An amount of Rs. 225 lakhs has been provided in the budget for under the National Smallpox Eradication Programme for assisting the States and Union Territories for carrying out the vaccinations against Smallpox throughout the country. Freeze dried vaccine (both Russian and indigenous) is supplied to the various State Governments and the Union Territories and the cost of such vaccine is borne by the Central Government. The cost of additional vaccinator: and other ancillary staff appointed after 1st April, 1969, is not tirely by the Central Government. Vehicles obtained through the W.H.O. are also being supplied to the States to increase the mobility of the vaccinating staff.
- (ii) B.C.G. Vaccination against T.B. B.C.G. Vaccination is being carried out as a part of the National T.B. Control Programme through the District T.B. Clinics established in Clinics. various States. In such B C.G. Teams are appointed who go round and carry out the necessary vaccination. A sum of Rs. 17.20 lakhs has been provided for meeting cost of B.C.G. Vaccine during 1973-74. 297 B.C.G. Teams have been established so far out of which 225 were already functioning at the beginning of the IV Plan period. The Government of India will meet the cost of additional Teams, i.e., 72 upto a limit of Rs. 25,000/- per team.
- (iii) and (iv) Immunisation of infants and pre-school-age-children and expectant mothers.—An amount of Rs. 15.84 lakhs has been provided during 1973-74 for immunisation of 28.47 lakhs infants and pre-school-age children against D.P.T. and 5.35 lakhs expectant mothers against Tetanus. These immunisation programmes are implemented through the Maternal and Child Health and Family Planning Institutions.

Deterioration in Academic Performances of I.I.T., Delhi

THE MINISTER OF EDUCATION, SOCIAL WELFARE AND CULTURE (PROF. S. NURUL HASAN): (a) and (b). A Reviewing Committee was ap-
