(a) whether his attention has been drawn to the news item of 'Sunday Standard' of 1st April, 1973 under the caption "Jobless in mustard oil units feared" stating that about 2,500 persons employed by mustard oil producing ghani unit might be rendered jobless if Vanaspati Manufacturers were allowed to use oil in their products,

(b) whether this crisis will arise due to stoppage of Canadian rapeseeds, which provides a substitute of mustard oil to West Bengal,

(c) if so, what advance steps Government propose to take to provide jobs for these persons who will become jobless in West Bengal, and

(d) the extent to which it will effect the economy of West Bengal and the total number of persons likely to become jobless?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (PROF SHER SINGH): (a) Yes, Sir However, the fears expressed m it are considered unfounded

(b) Import of Canadian rapeseed was arranged for the first time in 1970-71 as a purely temporary measure with a view to relieving the overall shortage of edible oils in the country There is, therefore, no connection between the continuance or stoppage of these imported supplies and the functioning of the mustard oil units in any particular State As it happens, a monthly allotment of 2,000 tonnes of imported rapeseed continues to be made to West Bengal.
