Upgradation of the Trichinapoly Station of All India Radio

1561. SHRI M. KALYANASUNDA-RAM: Will the Minister of INFOR-MATION AND BROADCASTING be pleased to state:

- (a) whether there is any proposal to upgrade the Trichinapoiv Station of the All India Radio; and
 - (b) if so, the main features thereof?

THE DEPUTY MINISTER IN THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI DHARAM BIR SINHA): (a) No, Sir.

Compensation for supply of defective Cross-Bar Telephone Exchange Equipment

1562. SHRI TRIDIB CHAUDHURI: Will the Minister of COMMUNICATIONS be pleased to state:

- (a) the compensation claimed by Government from the Bell Telephone Manufacturing Company for the supply of defective cross-bar telephone exchange equipment for Indian Telephones and what amount the Company has agreed to pay for the rectification of the equipment;
- (b) by what time the programme for rectification would be completed and what would be its total costs; and
- (c) whether any investigations have been made, Departmental or otherwise, of the circumstances under which contracts came to be placed with the B.T.M. for the supply of Cross-Bar equipments?

THE MINISTER OF COMMUNICATIONS (SHRI H. N. BAHUGUNA):
(a) M/s, B.T.M. have supplied free of cost replacement materials for the defective components of the Cross-bar exchange equipment supplied by them. The Company has also agreed in principle to bear the cost of manpower required for executing the modification. However, as the work

is on, the final amount will be determined at the close of the exercise.

- (b) The programme for rectification of Cross-bar Exchanges supplied by M/s. B.T.M. is estimated to take about one year in case of Delhi and Madras Exchanges and about 18 months in case of Bombay exchanges. However, the nature of work which is to be carried out in working exchanges is very complex hence the time it dicated is only approximate. The progress of the rectification is under constant review. The total cost is yet to be finalised as indicated in (a) above.
- (c) No investigations have been made. Orders were placed with M/s. B.T.M. for the supply of cross-bar equipment, after due scrutiny of tenders invited on a global basis.

Unearthing .a vice ring involving trafficking in Adivasi girls by Orissa Police
