THE MINISTER OF DEPENCE (SHRI JAGIIVAN RAM): (a) Since, in Army, due to historical reasons and on grounds of tradition, certain class compositions are continuing. There is reservation and weightage in recruitment, for members of certain cates only, on the basis of the existing class compositions. In the Navy and Air Force as there is no class composition, there is no reservation or weightage for any caste.

(b) There is no distinction between martial and non-martial races for recruitment to the Armed Forces. The policy of the Government is to provide equal opportunities to all citizens for enrolment in the Armed Forces.

(c) Does not arise.
