THE MINISTER OF COMMUNICA-TIONS AND TOURISM AND CIVIL AVIATION (SHRI RAJ BAHADUR): (a) and (b). Overtime allowance paid to staff for extra work done arising due to shortage of staff below sanctioned strength, absenteeism in excess of leave reserve, sudden rush of work and for work of urgent nature. It has no direct relation to the Development expenditure. However on account of economy drive under Non-Plan expenditure, instructions have issued to the Heads of Circles in September, 1973 asking them to ensure that expenditure on O.T. does exceed the budgetary allotments already intimated to them.
