## Rehabilitation of Repatriates from Sri Lanka

1696. SHRI M. KATHAMUTHU: SHRI S. A. MURUGANAN-THAM:

Will the Minister of SUPPLY AND REHABILITATION be pleased to state:

- (a) whether Government are aware of the fact that a number of evacuees who came from Sri Lanka are facing lot of difficulties as Government have not provided proper relief and rehabilitation facilities to them and if so, Government's reaction thereto;
- (b) the total number of such evacuees in India at present; and
- (c) the relief and rehabilitation facilities offered to them?

THE DEPUTY MINISTER IN THE MINISTRY OF SUPPLY AND RE-HABILITATION (SHRI G. VEN-KATSWAMY): (a) The Government of India have accepted the responsibility of the relief and rehabilitation of the repatriates from Sri Lanka coming to India under the Indo-Ceylon Agreement, 1964. Various measures for giving adequate relief to the repatriates on their arrival from Sri Lanka have been undertaken with the co-operation of the Government of Tamil Nadu. Specific schemes for rehabilitation like Plantations, resettlement in agriculture and employment in industries have been sanctioned in the States of Tamil Karnataka, Kerala and Andhra Pradesh and Andaman and Nicobar Islands. All these schemes are plemented by the State Governments and the Chief Commissioner, Andaman and Nicobar Islands. In addition the State Governments and the Chief Commissioner have been authorised to grant loans for trade|business besides housing subject to certain prescribed ceilings. The Government of India provide the necessary funds to the State Governments by way of grants and loans for the various relief measures and rehabilitation schemes.

- (b) 1,20,023 persons (28,584 families) of Indian Origin have arrived from Sri Lanka so far.
- (c) A Statement giving details of the schemes for relief and reheabilitation of Sri Lanka repatriates is laid on the Table of the House. [Placed in Library. See No. LT-5769/73].

## Pakistant P. O. Ws. Killed while Attempting to Escape

- (a) how many of Pakistani Prisioners of War were killed while attempting to escape or creating trouble in camps; and
- (b) how many of them are missing from their camps?

THE MINISTER OF DEFENCE (SHRI JAGJIVAN RAM): (a) Sixteen Pakistani prisoners of war were killed in their attempts to escape and thirty-five were killed while creating trouble in camps.

(b) Twenty-two Prisoners of war, who escaped from Prisoners of War camps, are still at large.
