- (2) Non-availability of Medical and qualified para-medical staff; and
- (3) Delays in getting acceptance of the State Governments for the provision of hospitalisation and specialist consultation facilities for the prospective C.G.H.S. beneficiaries in such cities, where the Scheme is proposed to be extended.

## Central Team for New Ports in Saurashtra and South Gujarat

2169. SHRI P. G. MAVALANKAR. Will the Minister of SHIPPING AND TRANSPORT be pleased to state:

- (a) whether Central Government Team visited Gujarat recently with a view to exploring the possibility of constructing new ports in Saurashtra and in South Gujarat;
- (b) if so, broad outlines of the report submitted by the said team; and
- (c) the steps Government propose to take in the matter?

THE MINISTER OF SHIPPING AND TRANSPORT (SHRI KAMLAPATI TRIPATHI): (a) A Committee appointed by Central Covernment to study the question of provision of facilities for ships at various minor ports, and other matters, visited some ports in Gujarat in September, 1973.

THE MINISTER OF EDUCATION, SOCIAL WELFARE AND CULTURE (PROF. S. NURUL HASAN): The University Grants Commission has selected 12 Universities for implementing the 'Plan of Action' for Examination Reform. These Universities will serve as a pace setter for introducing similar innovations in the neighbouring universities.

Assistance will be provided to the Universities for Examination Reform programmes by the Commission within the available funds.

## Applications from the Central Government Employees of Ahmedabad for loans towards purchase of Houses

2171. SHRI P. G. MAVALANKAR: Will the Minister of WORKS AND HOUSING be pleased to state:
