THE DEPUTY MINISTER MINISTRY OF LABOUR (SHRI BAL GOVIND VERMA): (a) to (c). The per capita daily earnings have not declined since 1969; the figures of per capita daily earn. ings of Factory workers (earning less than Rs. 400/- per month) as per returns under the Payment of Wages Act for 1969, 1970 (Provisional) are Rs. 8.17. Rs. 8.39 and Rs. 9.04 respectively.

# Measures for security of Foreign Embassies in India

### Production loss to Public and Private Sector, Steel Plants due to Railway trouble

- 2233 SHRI SWARAN SINGH SO-KHI: Will the Minister of STEEL AND MINES be pleased to state :
- (a) whether Public and Private sector steel plants incurred heavy production loss due to the recent Railway troubles In the country: and
- (b) if so, the amount of the losses in tonnage and price, be stated Plant-wise and the action Government propose to take to avoid such losses in future?

## THE DEPUTY MINISTER IN THE MINISTRY OF STEEL AND MINES (SHRI SUBODH HANSDA): (a) Yes, Sir.

(b) The aggregate production of ingot steel from the five major steel plants in the public and private sectors during the months of January and February, 1974, fell short of the targets for these months by about 2,79,000 tonnes. Since production in an integrated steel plant is dependent on a number of factors, it is difficult to quantify precisely the loss of production (or the value of production lost) directly attributable to the dislocation caused on account of Railway troubles, though this was the main factor.

### Dealership for Scooters Manufactured by Scooters India Limited, Lucknow

- 2234. SHRI SWARAN SINGH SOKHI: Will the Minister of HEAVY INDUSTRY be pleased to state :
- (a) whether Government propose to give dealership to private parties or will have their own sales agencies throughout the country, for the scooters manufactured by Scooters India Limited Lucknow. Uttar Pradesh: and

THE DEPUTY MINISTER IN THE MINISTRY OF HEAVY INDUSTRY (SHRI DALBIR SINGH): (a) and (b), According to the scheme prepared by Scooter India Ltd., the retail outlets which will be established in the various parts of the country will be managed by engineermanagers who will be recruited from among unemployed engineers. The engineer-manager will be paid a commission on sales which, after meeting the expenses of managing the show-room and the service centre, will provide a net monthly income to him of about Rs. 1,000/- to Rs. 1,500/-. Efforts is to harmonize adequate and prompt after-sales with gainful employment of engineers.
