## Irrigation Facilities in Kerala

6112. SHRIMATI BHARGAVI THAN-KAPPAN: Will the Minister of IRRIGATION AND POWER be pleased to state:

- (b) the action being taken by Government for improving irrigation facilities in the State?

THE DEPUTY MINISTER IN THE MINISTRY OF IRRIGATION AND POWER! (SHRI SIDDHESHWAR PRASAD): (a) The irrigation potential from major, medium and minor irrigation schemes likely to be created by 1973-74 in Kerala is expected to be 23 per cent of the cropped area.

(b) Seven major irrigation projects with an ultimate irrigation potential of 3.28 lakh hac are already under construction in Kerala. In the Fifth Five Year Plan programme of Kerala, maximum possible provision is proposed to be made for these projects. It is expected that six of these irrigation projects, would be completed by the end of the Fifth Plan.
