This is being done in view of the sharp curvature of the existing take off point from Jamnagar to Bedi which is not suitable for Broad gauge, the lack of adequate space at Jamnagar for expansion at the existing location and to avoid congested and built up areas of Jamnagar Town. A new site for the Jamnagar station is being selected. A suitable Broad Gauge connection will be given to the Bedi Port from the proposed diverted alignment.
