THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI MOHD. SHAFI QURESHI): (a) Assistant Commercial Superintendent, Hubli and the Assistant Security Officer, Hubli.

- (b) The enquiry has since been completed. Goods Inspector, Miraj and Head Rakshak, Miraj have been held responsible and suitable action has been taken against them.
- (c) A letter was regaived from the General Secretary, All India Railway Commercial Clerks' Association requesting for an immediate enquiry into the alleged high handedness of R.P.F. personnel at Miraj. A copy of the pamphlet brought out in January 1973 against the attitude of the personnel of Railway Protection Force was also enclosed The salient features of the letter are as follows:
  - Alleged high-handed interference in TP/Shed working.
  - Challenging to arrest TP/ Shed staff, one by one, without any RHYME or REASON.
  - Steam Crane labourers taken to custody without reason on 22-1-1973 and paralysed crane working.
  - Slavaldar Rangiah insulted and man-handled Goods Inspector on 22-1-1973 in his office, challenging and threatening all commercial staff with arrest.

 Rama Křishnaiah, SIPF-MRJ behaved very ruděly and arrogantly with Goods Inspector on more than one occasion and argued in despicable manner.
