## Accumulation of Jute and Coal due to shortage of wagons

2652. SHRI M. SUDARSANAM · SHRI M. RAM GOPAL REDDY:

Will the Minister of RAILWAYS be pleased to state:

- (a) whether shortage of wagons has resulted in the accumulation of jute and coal at various stations; and
  - (b) if so, the remedial steps taken?

THE DEPUTY MINISTER IN THE (SHRI MINISTRY OF RAILWAYS MOHD. SHAFI QURESHI): (a) No Jute could not be cleared firstly due to prolonged strike in the jute industry and then the staff agitations and 'work-to-rule' in the Northeast Frontier Railway. Coal loading was affected, particularly in Bengal- Bihar coalfields by various causes like strikes, staff agitations, 'Go slow', bundhs, power shedding, squatting on track etc., which has frequently interrupted train runrung and created an artificial scarcity in wagon availability.

(b) Railways will have no difficulty in moving jute and coal traffic, given normal conditions of working.

# Mini Projects sanctioned by Rural Electrification Corporation in Madhya Pradesh

The Rural Electrification Corporation has sanctioned 14 Mini Projects of Madhya Pradesh State Electricity Board as on 28th February, 1974. These schemes involve a loan assistance of Rs. 62.128 lakhs for electrification of 122 villages and energisation of 472 pumpsets and power supply to 148 small scale industries. ## 18-Hour Duty for Lcomen on South Eastern Rallway

2655, SHRI V. MAYAVAN: SHRI NAWAL KISHORE SHARMA:

- (a) whether South-Eastern Railway has started 10-hour duty for the Locomen:
- (b) if so, since when and the number of trains covered thereby; and
- (c) when the new duty hours are proposed to be made applicable to all India level ?

THE DEPUTY MINISTER IN THE OF MINISTRY RAILWAYS (SHRI MOHD. SHAFI QURESHI): (a) to (c). Implementation of 10-hour duty for Loco Running staff was commenced by the South-Eastern Railway on 1st December, 1973. Since then all Mail/Express trains and 9 passenger trains have been covered. Goods trains running on seven selected sections have also been covered.

Similar action has been taken by other Railways.

THE MINISTER OF IRRIGATION AND POWER (SHRI K. C PANT): (a) and (b). During the Fourth Plan period; One major and Ten medium new approved irrigation schemes were taken up for execution. Two of these medium schmes are likely to be completed during the Fourth
