THE DEPUTY MINISTER IN THE MINISTRY OF IRRIGATION AND POWER (SHRI SIDDHESHWAR PRA-SAD): (a) to (c). In West Bengal, power restrictions are in force in respect of power supply to the industries and other sectors since the power availability is short of demand. The augmentation of power generating capacity in the State has not

written representation and the submissions kept pace with the demand and plant availability was also low, resulting in the shortages. With the stabilising of new generating unit of 120 MW at Santaldih, and augmentation of generating capacity in West Bengal System during the course of the Fifth Plan and improvement in plant operations the power position will improve considerably. During the Fifth Plan period, additional generating capacity to the extent of 768 MW is proposed to be commissioned in the State. A close watch is being kept on the progress of projects under construction so as to enable their being commissioned on schedule.
