Forced distribution of Diesel Oil from a Tanker on way to NABHA

On the way, however, the tank lorry was stopped by a larger crowd of farmers collected at another petrol pump who requested for diesel to be issued to them since they were waiting for a long time. The District Authorities rushed to the spot and considered it proper to get the diesel oil issued on payment to the waiting farmers

Impact of shortage of Furnace Oil on Bread
