Setting up of a Crude Oil Conditioning Plant in Assam

2739 SHRI Y. ESWARA REDDY : Will the Minister of PETROLEUM AND CHEMICALS be pleased to state :

(a) whether a Crude Oil Conditioning Plant is going to be set up in Assam; and

(b) if so, the broad features thereof and when it is expected to be commissioned ?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND CHEMICALS (SHRI SHAHNAWAZ KHAN) : (a) and (b). A Crude Oil Conditioning Plant is being set up at Moran at an estimated cost of Rs. 3.5 crores to condition ONGC crude for transportation through pipeline. Its designed nominal capacity will be to condition crude at the rate of 1.25 million tonnes per annum. The project is expected to be completed in early 1973.

Over-bridge for Pedestrians at Ratangarh

2740. DR. KARNI SINGH : Will the Minister of RAILWAYS be pleased to state :

(a) whether the Rajasthan Government have since agreed to contribute their share for the construction of an over-bridge for pedestrians at Ratangarh;

(b) if so, the progress made in this regard; and

(c) if not, what steps Government propose to take to mitigate the sufferings of the people ?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI MOHD. SHAFI QURESHI) : (a) to (c). There is no proposal for construction of an overbridge for the pedestrians in Ratangarh yard. However, there is a proposal for the construction of an under-bridge in place of the existing level crossing No. C/191 in Ratangarh yard. The State Government/local Municipal Authority have not conveyed their acceptance to bear their share of cost of the road under-bridge so far. The matter now rests with the Ratangarh Municipal Authority.

Import of Kerosene from USSR and its distribution to States

2741. SHRI S. M. BANERJEE : Will the Minister of PETROLEUM AND CHEMICALS be pleased to state :

(a) the total quantity of kerosene oil received from USSR to meet the shortage in India;

(b) how this has been distributed to the various States; and

(c) whether more kerosene oil is expected to be imported from USSR ?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND CHEMICALS (SHRI SHAHNAWAZ KHAN) : (a) to (c). Indian Oil Corporation has entered into a contract with Soviet suppliers for import of only 1 million tonnes of Kerosene oil during 1974.

Kerosene Oil quotas are *inter-alia* based on total availability of the product and no separate allocation of imported product alone is made.

Electrification of Harijan Basties in States

(a) whether a Centrally sponsored special scheme for electrification of Harijan Basties, which was initiated in 1971 to
