Construction of Railway Line from Dharannagar to Agartala

(a) the progress of the survey for the construction of Railway Lines from Dharamnagar to Agartala in Tripura;

(b) whether Government have arrived at a decision to undertake this work soon; and

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI MOHD. SHAFI QURESHI): (a) to (c). Preliminary Engineering and Traffic Dharmnagar-Agartala Surveys for the M. G. line have been completed and the reports are under examination. It has, however, been decided to take up the construction of a new M. G. line from Dharamnagar to Kumarghat for which the North Eastern Council has been requested to bear the cost out of the funds allotted to it for development of backward areas. Construction of the remaining portion of the line from Kumarghat to Agartala may be taken up sometime during the 5th Five Year Plan period subject to availability of additional resources.
