THE PRIME MINISTER, MINISTER OF ATOMIC ENERGY, MINISTER OF ELECTRONICS AND MINISTER OF SPACE (SHRIMATI INDIRA GANDHI): (a) to (c). The restricimposed Canada by supply of equipment the and components for use in actors which are not under safeguards acceptable to them has affected the progress of the Madras Atomic Power Project (MAPP) in that alternative sources of supply for equipment for which orders were or were to be placed on manufacturers in Canada have now to be located. Arrangements have been made to locate alternative suppliers indigenously, wherever possible. Where this has not been possible, suitable alternative sources of supply being located abroad. As finalisation of these arrangements will necessarily take time, this will cause some delay in the completion of MAPP. Constand efforts are, however, being made to complete the construction of MAPP as early as possible. It will not be in the public interest to disclose the names of the countries which have expressed willingness to supply equipment for MAPP.
