THE DEPUTY MINISTER IN THE MINISTRY OF COMMERCE (SHRI A C GEORGE) (a) Yes, Sir

(b) Certain Centrally Sponsored Schemes on horticulture development mainly for export purposes have been recommended by this Council for implementation during the Fifth Five Year Plan

Cyclone warning system and maritime rescue measures

8288. SHRI P. GANGADEB: SHRI RAGHUNANDANLAL BHATIA:

Will the Minister of TOURISM AND CIVIL AVIATION be pleased to state:

(a) whether Government have taken any steps to improve the cyclone warning system and maritime rescue measures; and

(b) if so, the nature thereof?

THE MINISTER OF STATE IN THE MINISTRY OF TOURISM AND CIVIL AVIATION (DR. SAROJINI MAHISHI): (a) and (b). Yes, Sir. Steps have been taken to improve the cyclone warning system along the east cost by installing four cyclone warning radars at Calcutta, Paradeep, Vishakhapatnam and Madras. Four more such radars are proposed to be installed at Masulipatnam and Karaikal on the east coast and Bombay and Goa on the west coast. Satellite monitoring stations have

set aip at the cyclone warning centres of Calcutta, Madras and Bombay with the help of these modern scientific aids, it will be possible to issue accurate warning to ships at sea, and the public in the coastal areas.

All air/sea search and rescue operations around the coast are conducted under the overall direction of the Air Force by their aircraft, aircraft under the control of the Civil Aviation Department, ships of the Indian Navy and merchant ships present in the vicinity.

Advisory Council to help small planners

\$289. SHRI K. MALLANNA Will the Minister of FINANCE be pleased to state:

- (a) whether the Agricultural Refinance Corporation had decided to constitute an advisory council with a view to helping the small planners;
- (b) whether the recommendations of the working group on finance for tea industry have also been accepted; and
- (c) if so, the calient features regarding these recommendations and whether they will be applicable to all the plantation crops?

THE DEPUTY MINISTER IN THE MINISTRY OF FINANCE (SHRI-MATI SUSHILA ROHATGI): (a) Presumably the reference is to small planters.

, Yes, Sir; the Agricultural Refinance Corporation has set up an Informal Advisory Committee comprising representatives of Commodity Boards, Government of India, State Governments of Kerala, Karnataka and Tamil Nadu, commercial banks, land

development banks and non-official organisations like United Planters Association of Southern India. The Corporation proposes to set up similar units for other areas also.

(b) and (c). The information is contained in the enclosed statement.

Statement

The major recommendations of the Working Group on Finance for Tea Industry set up in September, 1971 by the Reserve Bank of India, relating to the Agricultural Refinance Corporation and action taken thereon were as under:

(1) The Working Group had recommended the adoption of a consortium arrangement for parties, who experienced difficulties in mesting security requirements of the institutions providing different types of credit. The tea Estate would form a common security by way of equitable mortgage for all the lending institutions which provide term finance and working finance on a pari passu basis. Where one of the participating institutions is not eligible for refinance. the Agricultural Refinance Corporation should have no objection to sharing the security with that institution.

The Agricultural Refinance Corporation has agreed to this recommendation. It has as a matter of policy, decided that it would not insist on any security for refinance provided to the licensed scheduled commercial banks, depending upon the merits of each case. This relaxation would be applicable to tea plantations also.

(2) The Agricultural Refinance Corporation should provide 80 to 94 per cent refinance and in deserving cases even upto 100 per cent of the development loans extended. State Financial Corporation could be made eligibble for refinance assistance from Agriculturaly Refinance Corporation.
