### Profit earned by D.T.C.

2150. PROF. NARAIN CHAND PARASHAR: Will the Minister of SHIPPING AND TRANSPORT be pleased to state:

- (a) whether the Delhi Transport Corporation has shown any profit since its inception;
- (b) if so, the amount of profit earned by the Corporation;
  - (c) if not, the reasons therefor; and
- (d) the steps taken/likely to be taken by Government to better its working?

THE DEPUTY MINISTER IN THE MINISTRY OF SHIPPING AND TRANSPORT (SHRI PRANAB KUMAR MUKHERJEE): (a) No. Sir.

- (b) Does not arise.
- (c) The main reasons for the Delhi Transport Corporation not earning any profits are the high cost of operation of its buses and telescopic rates of fares for its services which have not been revised since 1964, resulting in a wide gap between expenditure and income.
- (d) Construction of new depots, renovation of existing depots and purchase of additional equipment for the Central Workshop, so as to improve the maintenance facilities, augmentation of the fleet and restructuring of the routes on a more scientific basis are some of the main steps being taken to improve the earnings of the Corporation.

#### Central Universities closed during 1973-74

- (a) the number of times each one of the Central Universities were closed during the academic year 1973-74 because of various disturbances including student unrest;

THE MINISTER OF EDUCATION, SOCIAL WELFARE AND CULTURE (PROF. S. NURUL HASAN): (a) to (c). According to the information received from Aligarh Muslim University, Banaras Hindu University, Delhi University. Jawaharlal Nehru University and North-Eastern Hill University, none of them was closed during the academic year 1973-74 on account of student disturbances. Information in respect of Visva-Bharati is being collected and will be laid on the Table of the Sabha,

## Delay in Expansion of Public Sector Metropolitan Milk Scheme

2152. SHRI N. K. SANGHI: Will the Minister of AGRICULTURE be pleased to state:

- (a) whether a scheme for expansion of four public sector metropolitan milk schemes has been delayed for nearly three years;
- (b) if so, the year-wise target fixed for achieving the expansion schemes during the last three years and how this was achieved or not achieved;
- (c) to what extent the expansion scheme was dependent on imported

milk powder and gift of milk powder separately; and

(d) the present thinking of Government?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI B. P. MAURYA): (a), (b) and (d). Under Project WFP 618 (Operation Flood) the expansion of four metropolitan dairies was to be completed during the second year of the project, as under:—

The expansion was delayed due to late arrival of gift equipment from UNICEF. However, the target has been reached in case of Madras while the expansion in the case of Delhi, Bombay and Calcutta is likely to be completed shortly.

(c) The expenditure on the expansion schemes was to be made out of the funds generated from the sale of gift skim milk powder and Butter Oil.

### Sale of books published by Urdu Board

(a) whether the books published by the Urdu Board are already being put out by the National Book rust, another Government Underking:

THE DEPUTY MINISTER IN THE MINISTRY OF EDUCATION SOCIAL WELFARE AND IN THE DEPARTMENT OF CULTURE (SHRI D. P. YADAV): (a) to (c). The National Book Trust, an autonomous organisation, agreed to arrange the printing of Urdu manuscripts prepared under the auspices of the Taraqui-e-Urdu Board in the formative stage. The Trust also agreed to cover the distribution and sale of such books through its sales organisation. This arrangement has continued so far. There is no overlapping involved in this arrangement In fact, duplication by creation of a separate sales machinery under Board in its formative stages, thus been avoided The work of the Board has, however, increased now, and the most suitable arrangement for getting the books printed and sold is under consideration in the light of the changed situation.
