Complaint against Issue of Industrial Licences to Eastern States

3745 SHRI N K SANGHI Will the Minister of INDUSTRIAL DEVELOPMENT AND SCIENCE AND TECHNOLOGY be pleased to state.

(a) whether the Chief Minister of West Bengal has complained to the Centre that discrimination is being shown by the Centre towards the Eastern States including West Bengal in matters of issuing industrial licences,

- (b) if so, whether Government have examined the precise grounds on which the complaint was made; and
- (c) if so the outcome of the enquiry and the nature of steps taken to set right the imbalance?

THE MINISTER OF INDUSTRIAL DEVELOPMENT AND SCIENCE AND TECHNOLOGY AND CULTURE (SHRI C SUBRAMA-NIAM) (a) to (c) In April, 1974, the Chief Minister of West had addressed a letter to the Minister of Industrial Development about the alleged neglect of the eastern region in the matter of industrial licensing The letter was duly examined and the Union Minister in his reply explained that the number of letters of intert issued for a State depends upon the quantity of aplications received from the State as also on their quality namely, the extent to which applications relate to wellconceived investment proposals that conform to our policies and priorities There can be no question of discilmination, even in any implicit or unconscious fashion, for or against any region in India In fact, analysis of letters of intent issued over a threeyear period (1971-73) has shown that West Bengal has accounted for 29 per cent of the approvals, which is not too far below the all-India average of 32 per cent for the major states However, the Chairman of the Licensing Committee has been quested to give particular attention to applications from the eastern region.
