(b) Under the agreement signed by the Governments of India and the Federal Republic of Germany on 31st December 1971 the latter has agreed to provide technical assistance to India in various development sectors in the shape of services of experts, equipment and training awards for Indian nationals The Government of the FRG will pay the German experts' salaries and international travel costs, meet the cost of ocean transportation of equipment and supplies pay suitable allowances and international travel costs and other expenses within Germany for Indian trainees The Government of India will meet the local costs on payment of salaries of Indian personal, provision of materials and equipment of indigenous manufacture make available office accommodation and a suitable allowance to cover residential accommodation and duty trips in India of experts and arrange payment of customs duty on import of specified household effects and stores for the personal use of the experts
