THE DEPUTY MINISTER IN THE MINISTRY OF SUPPLY AND RE-HABILITATION (SHRI G. VENKAT-SWAMY): (a) No, Sir,

- (b) A statement is laid on the Table of the House. [Placed in Library, See No. LT-8474/74].
- (c) Plans for resettlement of 21,300 families during the Fifth Plan period have been formulated. Of these, 15,600 families are planned to be resettled on agricultural lands and 5,700 families on non-agricultural occupations, subject to availability of suitable lands and adequate funds.

## Reaction of various countries over Associate St. tehood to Sikkim

586. SHRI SAMAR GUHA. SHRI R. S. PANDEY. SHRI NOORUL HUDA:

Will the Minister of EXTERNAL AFFAIRS be pleased to state

- (a) reaction of various countries of the world about incorporation of Sikkim as an Associate State of India,
- (b) the reaction of Bangladesh, Nepal, Ceylon, Pakistan and other neighbouring countries of India in particular;
- (c) the steps taken by India to explain her position ris-a-ris Sikkim,
- (d) whether Indo-Sikkimes. :elations will now be dealt with by the Ministry of External Affairs or by the Ministry of Home Affairs, and
- (e) the constitutional rationale behind such a measure?

THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFT-AIRS (SHRI BIPINPAL DAS): (a) and (b). Except for China, Pakistan and Nep il no country has reacted adversely to Sikkim being associated with the Union of India. The reaction of China and Pakistan has been hostile in Nepal, after an initial adverse reaction, there is a somewhat

better understanding of the real situation.

- (c) Our position has been fully explained in official discussions by our Heads of Mission, press briefings etc.
- (d) Indo-Sikkim relations continue to be looked after as hereto before by the Ministry of External Affairs.
- (e) The Constitutional Amendment formalises the situation existing heretobefore. It gives effect to the wishes expressed by the people of Sikkim through their elected representatives.

AIRS (SHRI BIPINPAL DAS): (a) A statement giving increases and decreases in staff strength (under the control of Ministry of External Affairs) in the Indian Missions abroad during the period from 1st January to 31st October, 1974 is laid on the Table of the House, [Placed in Library See No. LT-8475/74].

- (c) The matter is kept constantly under review and Foreign Service Inspectors visit the Missions periodically to assess their optimum staff
