- (a) whether a recent study revealed that foreign exchange allocation to the registered exporters have increased manifold; and
- (b) if so, the reasons therefor and the amount of foreign exchange released in the years 1972-73, 1973-74, 1974-75?

THE MINISTER OF FINANCE (SHRI C. SUBRAMANIAM): (a) Import licences are issued to the Registered Exporters in accordance with the provisions of the Import Trade Control Policy for the relevant fiscal year, and no separate foreign exchange allocation, as such, is made in favour of the Registerd Exporters.

(b) The value of import licences and release orders issued under the Registered Exporters Scheme during 1972-73, 1973-74 and 1974-75 (upto 27-7-74) is as under.

वाणिष्य मंत्रालय में उपमंत्री (श्री विश्वनाथ प्रताप सिंह): (क) और (ङ) उपभोक्ता वस्तुयों का उल्लेख मुख्यतः झत्यात व्यापार नियन्त्रण सूची के भाग 4 में किया जाता है इन मदों पर लागू होने वाली झायात नीति वर्ष 1974-75 के लिए आयात व्यापार नियंत्रण नीति (रेड बुक) खण्ड 1 में दी गई है। इन वस्तुयों से सम्बन्धित आयात आंकड़ वाणिष्यक जानवारी तथा श्रंक बलन के महानिदेशक, कलकता द्वारा प्रकाशित किए जाते हैं।

Lock-out in Indian Airlines

767 SHRI NOORUL HUDA: Will the Minister of TOURISM AND CIVIL AVIATION be pleased to state:

- (a) the reason why the lock-out declared in the Indian Airlines some months ago has not been completely lifted as yet;
- (b) whether the dispute between the Indian Airlines management and its employees has been amicably settled; and
- (c) whether Government have received reports of excessive work-load on employees after declaration of the lock-out?

MINISTER OF TOURISM THE AVIATION (SHRI AND CIVIL RAJ BAHADUR): (a) and (b) Of the 15,977 employees in the service of the Corporation before the lockout, all but 10 have resumed duty, either after the Unions representing them had signed settlements with the management agreeing to work according to the new shift system and cooperate with the management in eliminating wasteful work practices or on individual employees themselves giving such undertakings. The lockout has been lifted in respect of all such employees. Only one union viz. Air Corporations Employees' Union, whose membership extends to more than 11,000 employees of the nontechnical categories is yet to sign such a settlement, although all the employees represented by this Union, excepting 10, have signed individual undertakings and resumed duty. The lock-out in respect of the remaining 10 employees will be lifted as soon as they give individual undertakings or when the Air Corporations Employees' Union reaches a settlement with the management.

(c) No, Sir.

New Leaders of Smugglers' Gangs

(a) and (b) The Government have not received any specific information in this regard. However, the activities of smugglets are kept under constant watch and the preventive staff is deployed and intelligence operations are geared up according to the needs of the situation.
