## Setting up of a Unit in Public Sector to Manufacture Electronic Components

4954. SHRIMATI PREMALABAI CHAVAN: Will the Minister of SCIENCE AND TECHNOLOGY be pleased to state:

- (a) whether the Government are planning to set up a unit in the public sector to manufacture electronic components with the know-how developed by C.S.I.R.; and if so, the main features thereof;
  - (b) whether the above unit is to be set up in New Delhi or any other metropolitan area; and
  - (c) if so, the reasons for selecting a metropolitan area, in view of the overcrowding of large cities and industrial concentration?

THE MINISTER OF INDUSTRY AND CIVIL SUPPLIES AND SCIENCE AND TECHNOLOGY (SHRI T. A. PAI): (a) The Central Electronics Limited has been set up as a Public Sector Undertaking under the Department of Science and Technology in June, 1974. The Electronic Components Production unit of the National Physical Laboratory under the Council of Scientific and Industrial Research is being taken over by the Central Electronics Limited. Soft Ferrites, Pot Cores, Memory Cores, Ceramic Capacitors and other etectronic components are in the Company's manufacturing programme. Some of the products are expected to be marketed in 1975-76.

- (b) It is not proposed to locate the factory in New Delhi or any other metropolitan area.
