(17) Provision for payment of travel grant to scientists and their families who, on their selection for appointment in research institutions in India may give undertaking to serve those institutions for a minimum period of three years.

#### Tourist Traffic to Eastern and North Eastern Region

2206. SHRI BISHWANATH JHUN-JHUNWALA: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether some of the areas in West Bengal have been thrown open to foreign tourists without corresponding steps being taken to simplify administrative procedure as to encourage foreign tourists;
- (b) whether as a result of this, the foreign tourist traffic has not shown any appreciable increase even though the Eastern and North Eastern parts of India abound in places of scenic beauty; and
- (c) if so, whether suitable steps would be taken to encourage foreign tourists to visit this region of the country?

THE DEPUTY MINISTER IN THE MINISTRY OF HOME AFFAIRS (SHRI F. H. MOHSIN): (a) It was decided in August, 1974 to allow foreign tourists to visit Darjeeling town without permits under the Foreigners instricted Areas) Order, 1963, for atmy upto 15 days provided they travel by air to and from Bagdogra en-route to Darjeeling.

(b) and (c). Since the relaxation was made only in August, 1974, it is too early to assess its impact on tourism.

## Illegal transactions in foreign exchange by Foreign Missionaries

2207. SHRI DEVINDER SINGH GARCHA: Will the PRIME MINIS-TER be pleased to state:

- (a) the number of foreign missionaries rounded up so far in various parts of the country for their involvement in irregular foreign exchange transactions; and
- (b) what is the length of their stay in India and to which country they belong to?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS. DEPARTMENT OF PERSONNEL AND ADMINISTRATIVE REFORMS AND DEPARTMENT OF PARLIAMENT-ARY AFFAIRS (SHRI OM MEHTA): (a) and (b). During the last two years two cases of alleged contravention of the Foreign Exchange Regulations Act involving individual foreign missionaries have been registered by the Directorate of Enforcement, Both these individuals are reported to be Americans. One of them is stated to be residing in India for a long time and the other is stated to be normalry residing outside India.

कर्ना मंत्रालय में उप मंत्री (मी० सिद्धेक्बर प्रसाद) :(क) 1974-75 में लिए निर्मारित लक्ष्य को प्राप्ति के लिए मई नई परियोजनाएं प्रायम्भ की गई है। इनके श्रन्ते कार्यान्वयन के लिए अधिक अधिकार प्रदान किए गए है। महत्वपूर्ण निवेणों सम्बन्धी बाधाओं को दूर करने के लिए विशेष कार्रवाई की गई है। अतिरिक्त बिजली तथा मान डिटवे प्राप्त करने के लिए कमण: विजली और नेत्र प्राधिकारियों से निकट का सम्पर्क स्थापित किया जा रहा है।

(ख) जी हो । 1973-74 में मध्य प्रदेश की खानों से लगभग 155 लाख टन कोथले का उत्पादन हमा। 1974-75 में इस उत्पादन की बढ़ा कर 180 लाख टन करने का कार्यक्रम है। चाल वर्ष के पहले 7 महीनों में 1973-74 को इसी ग्रवधि के उत्पादन से 17 प्रतिजन ग्रधिक उत्पादन हमा है।

#### Disconnection of the Telephones of Smugglers

## 2210. SHRI K. M. MADHUKAR: SHRI SHRIKRISHNA AGRAWAL:

Will the Minister of COMMUNICA-TIONS be pleased to state:

- (a) whether Government have taken any steps to disconnect telephone connections of smugglers who have been detained under MISA and of others who help them;
  - (b) if so, the facts thereof; and
- (c) the number of telephones disconnected State-wise with their names?

THE MINISTER OF COMMUNI-CATIONS (DR SHANKER DAYAL SHARMA): (a) and (b). Action to disconnect telephones can be taken only under the Indian Telegraph Act which permits disconnections for unauthorised use. Wheneverr such unauthorised connections are detected among subscribers detained under MISA they are disconnected.

(c) The number of telephones disconnected under these provisions is being empiled.

## Production of Scooters by Allwyn Metal Works, Hyderabad
