THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI BUTA SINGH): (a) During 1974-75, passenger fares were revised twice, with certain exceptions. The first revision took effect from 1-4-1974. The additional earnings on account of this revision was estimated at Rs, 41.16 crores.

The fares were again revised from 15-9-1974 to compensate for the drop in anticipated earnings, anticipated additional yield being Rs. 40.33 crores during the period from 15-9-1974 to 31-3-1975.

(b) No. A short-fall of Rs. 15 crores is anticipated in passenger earnings compared to the budget estimates.

Restoration of Trains suspended for want of coal or other reasons
