(c) This new line scheme envisages participation of the Bihar State Government for bearing the cost of land and earthwork component of the project. The State Government have been asked to convey their acceptance in this regard but their final reply has not been received.

Attack on passengers of Bhojpur shuttle on Kharota Station

2082. SHRI BHOGENDRA JHA: Will the Minister of RAILWAYS be pleased to refer to the reply given to Unstarred Question No. 3917 or. 10th December, 1974 regarding attack on passengers of Bhojpur Shuttle on Kharota Station and state:

Amenities in Railway Quarters

2083. SHRI G. Y. KRISHAN: Will the Minister of RAILWAYS be pleased to state whether the workers of Railways residing in the Railway quarters are living in the same old state of affairs without light and sanitation?

THE DEPUTY MINISTER IN THE MINISTRY OF RAIL-WAYS (SHRI BUTA SINGH); No. All newly constructed staff quarters at places where

electricity is available are electrified along with their construction. A substantial number of old staff quarters, at stations where electricity is available, have already been electrified and the Railways are making steady progress in providing electricity in the remaining old staff quarters within the limits of availability of funds.

As regards sanitation the quarters are constructed according to the scales of accommodation laid down for various types of quarters which provide for sanitation facilities like individual bath-rooms and latrines. In the case of certain old quarters where these facilities do not exist, the same are being provided on a programmed basis.

Scheme for drilling in Cachar District of Assam

(a) and (b). Yes, Sir. On the basis of geological mapping, CNGC has released locations for drilling at the Chargola, Masimpur and Kanchanpur structures in Cachar district of Assam. Drilling at Chargola is expected to start in about a year's time.
