(b) to (d) The allotment of maida to the private bakeries is normally made by the State Governments keeping all relevant factors and demand by various sections of the consumers in view. The Central Government lays down broad guide-lines regarding the manner of purchase of wheat by the roller floor mills, the stocking limits and the fixation of prices of wheat products etc. The administrative control over the Roller Flour Mills is with the State Governments who exercise suit-

able control over the mills to eusure compliance with the various guidelines and instructions.
