minminations conducted by different times of Universities and also for examination at the elementary and secendary stages. Some important issues Mke Internal Assessment, Marks and Grades, National Examination Question Banks have been discussed. The report of the Working Group has been circulated to all the Governments to take immediate steps to implement these recommendations modifications as may be with such necessary to suit local conditions. A copy of the report has been placed in the Parliament Library

The University Grants Commission has generally endorsed the recommendations made by the Group and has circulated them to the Universities and Colleges for their guidance. The Commission has also appointed an Implementation Committee on Examination Reform.

One of the conditions of Central assistance for introduction of the new U.G.C. scales of pay is that no remuneration will be payable to teachers of Universities and Colleges in connection with examination work. This is likely to act as a catalyst for programme of examination reform.

It is hoped that implementation of examination reform along the lines suggested by the Group as also due to the condition linked with introduction of the new U.G.C. pay scales will help considerably in putting the examinations in proper perspective and in eliminating, to a considerable extent, the use of unfair means, and thereby improving the merit value of the examination results.

The procurement prices of wheat and paddy are fixed by Government after careful consideration of all relevant factors and keeping in view the commendations of the Agricultural Prices Commission which takes account the cost of production anđ suitable increases for the escalation in the cost of inputs etc.
